IMPORT REQUIREMENTS TO TIGHTEN FROM 1ST JANUARY 2022

Importers who bring goods from the EU will see a tightening of easements from the 1st January 2022. For example, there will be the need to complete full customs declarations and, depending on your goods, pre-notification via IPAFFS. Ensure that both you and your customs intermediary are ready to complete your new requirements!

The UK and New Zealand have agreed in principle a Free Trade Agreement. The trade agreement will cut red tape for SMEs throughout the UK. In terms of the wider picture, it joins the Australian and Japanese trade agreements in paving the way for the UK to join the large, multi-national Trans-Pacific Partnership on free trade.
